The geniuses at Huff Po haven't gotten the memo yet: blacking out information about the film only gives it more legs. Do they even have a press operation over there? I always assumed Huff Po was built as a façade/cardboard box, in order to sell it. That objective was achieved in 2010, when AOL gobbled it up for \$315 million. What an extraordinary hustle.

Huff Po can't even stomach allowing a positive review of [Vaxxed](#) to see the light of day. I wonder how they feel about vaccines causing brain damage—I mean the actual occurrence of it. Perhaps they don't care. Perhaps they're so far removed from the truth they don't even think about it. But I'm willing to bet at least a few people on the payroll know the reality of it, and under the surface they're boiling.

The CDC has large numbers of vaccine scandals buried in their files. One of them involves a vast over-exaggeration of flu deaths in the US every year. As researcher Peter Doshi noted, years ago, the old canned figure for annual flu deaths, 36,000, was a gross exaggeration. One year, the actual number of confirmed flu deaths in America—where the flu virus

was positively identified—was, wait for it: 18. Of course, the CDC uses those flu-death stats to convince Americans they must take the flu vaccine.

I've been doing my own research on the Panama Papers during the week and what it seems to boil down to is an off-shore wealth funds grab by the US/Rothschilds and Co through international tax compliance law - by getting all major offshore wealth fund holders to move their money to the new US tax haven states of Nevada and South Dakota, as the US government has opted out of OECD tax compliance acts which it forced all other western countries to sign up to.

Let me explain. As you know, the [ICIJ.org](http://ICIJ.org) NGO International journalist website clearly states it's funded by 9+ NGO/Trusts (1 NL, 1 UK and 7 US) including George Soros Open Society Foundation. So these have editorial oversight of what gets leaked and what does not. Few US citizens were leaked partly because of the 2010 US [FATCA](#) law (Foreign Account Tax Compliance Act) which forced Panama to share records of off-shore companies with the US government.

But on further investigation, what the ICIJ journalist (our Irish Times included) failed to inform the public is that in 2014 the international [OECD](#) tax compliance initiative - built on the 2010 [FATCA](#) law and which is enforced by the US government - forced offshore banks around the world to comply to provide access to deposit accounts under the guise of anti-terror and money laundering laws. Hidden in plain sight it that OECD registered office is [headquartered](#) in Paris (2 rue André Pascal 75116 Paris), the Parisian residence of the ROTHSCHILD - the oldest European banking dynasty.

The Rothschilds being a founding member of OECD have forced all banks in western countries (**except the US**) to comply, otherwise those countries banks risk being cut of international transfers in the dollar system. Example: Swiss banks have been fined \$5 billion to date.

So in the space of 8 years, the US/Rothschilds have done a coup d'état on the off-shore economy and turned the US into the de facto largest tax-haven in the world. The US sanctimonious position in portraying tax avoidance as unpatriotic and even criminal, has been turned on its head. **The US is now the new Switzerland.**

Today, all the major holders of off-shore accounts have moved their account to wealth fund management companies in the US states of Nevada and South Dakota, of which Rothschild and Co is the biggest wealth fund management company with an [office in Reno](#), Nevada, but directed from the City of London.

And now for some high octane Joseph Farrell type speculation from me :-)

It would not surprise me in the least that now most wealth funds are under US jurisdiction, that the Rothschild family turn around in months/years and screw their new account holders by permitting the US government to initiate the legislated 2015 **bail-in laws** (or others), and overnight “legally” confiscate a large percentage of those wealth funds on behalf of the US Treasury/IRS to the benefit of their creditor the Federal Reserve Bank to pay public debt - like Cyprus in 2011. The FRB shareholders are US commercial banks (JPMC, CityBank,...) many of which are owned by about a dozen European banking organisations mostly British and most notably the Rothschild banking dynasty.

Is this crazy speculation? Am I off track here. What’s your opinion on what happening Catherine? Your subscribers and I would love to know.

**Hello Catherine,**

I am a recent subscriber, after having heard a number of outstanding interviews you have had online. Prior to subscribing to your service, I

looked on the internet to find information about the ZKB ETFs and found your report dating back a few years. I wonder if you are still of the same opinion as you were about this ETF. Is the bullion underlying the ETF allocated or unallocated? As far as I know, it is claimed to be fully backed by bullion one to one, and ZKB as a bank does not engage in derivatives, so the implication is that one is protected from the fractional treatment gold gets in the GLD as well as other gold and silver ETFs.

### **ZKB – ETF – believe gold is there**

As a non-US investor, I have been a holder of these certificates for a number of years. When looking for information, I have found it hard to get anything of substance out of the ZKB PR telephone line.

**US Regulations has made it impossible for the Swiss to function by phone.**

**If I were in their shoes I would only respond to your list of questions if you were in Zurich and it was a verbal conversation.**

Recently I asked them the following questions (see below) and they replied that they would only be willing to deal with my custodian bank, and possibly not in writing. I was not very pleased with their reply as I originally put my money behind Switzerland in the knowledge and confidence they would always remain pro-privacy and independent of the EU. I did not expect them to be bullied so comprehensively by the US, France and Germany about the nature of their account holders back in 2010. Today, ask any Swiss person about this episode of Swiss banking and they are mostly of the opinion that not only did the Swiss banks roll over way too fast to US demands, but they suggest, and correctly in my opinion, that the entire destruction of European offshores was a means to an end for the US; i.e. a successful attempt to move capital from Europe to US offshore destinations in Nevada. I think this has been borne out in the last month or so, if not yet in statistical fact, certainly anecdotally.

**Agreed – although it was not the only agenda.**



So my trust in the Swiss resolve to remain independent is considerably weakened. Would the Swiss for instance participate in ECB IMF or BIS instigated continent-wide bail ins?...and where do these bail-ins stop? At the bond holder's level as we saw in Austria recently, at the cash depositors level, or perhaps even at the bullion holders?

What about confiscations? I don't know how this could be achieved in 28 disparate EU nations, but certain countries like France have been aggressive against gold holders in the last five years, banning the posting of bullion in the mail, which is the main method used by bullion brokers and numismatic shops to sell bullion online. Britain taxes silver purchasers with VAT, but not gold purchases. Holland seems to be happy to ship bullion anywhere. The rules are diverse for the time being, and that's an advantage. But these hungry European tax chasers are in my opinion only a small step away from taxing gold and silver as if property, or any other mainstream asset. So I wonder if Switzerland would follow suit.

Here are the questions I raised to ZKB. I will now readdress them to my bank and see what answers are forthcoming. Eventually, I would be happy to share their reply with you if this is of interest to you. I welcome any comments you have about my recently acquired concerns of holding ZKB.
