Lots of noise around the Electoral College three days from now on December 19th. The Electoral College will give the necessary majority to Trump. Ignore the noise.

The facts are consumer confidence is up since the election, small business confidence is up a lot and the stock market is up and the Republican party, the military and Goldman Sachs and Wall Street are on board and pleased by the transition so far; only Hollywood, Corporate media, the Washington bureaucracy outside the military and some intelligence and

On November 30, one week after the Washington Post launched its witch hunt against "Russian propaganda fake news", with 390 votes for, the House quietly passed "[H.R. 6393, Intelligence Authorization Act for Fiscal Year 2017](#)", sponsored by California Republican Devin Nunes (whose third largest donor in 2016 is Google parent Alphabet, Inc), a bill which deals with a number of intelligence-related issues, including Russian propaganda, or what the government calls propaganda, and hints at a potential crackdown on "offenders."

A quick skim of the bill reveals "Title V—Matters relating to foreign countries", whose Section 501 calls for the government to **"counter active measures by Russia to exert covert influence ... carried out in coordination with, or at the behest of, political leaders or the security services of the Russian Federation and the role of the Russian Federation has been hidden or not acknowledged publicly."**

The section lists the following definitions of media manipulation:

1. Establishment or funding of a front group.
2. Covert broadcasting.
3. Media manipulation.
4. Disinformation and forgeries.
5. Funding agents of influence.
6. Incitement and offensive counterintelligence.
7. Assassinations.
8. Terrorist acts.

As [ActivistPost](#) correctly notes, it is easy to see how this law, if passed by the Senate and signed by the president, could be used to target, threaten, or eliminate so-called “fake news” websites, a list which has been used to arbitrarily define any website, or blog, that does not share the mainstream media's proclivity to serve as the Public Relations arm of a given administration.

NOW FACEBOOK CENSORSHIP = The Fake News team accelerating their right to control news sites and have it presented as official fact.

Legitimate problem – truly fake stories designed to generate money from ads – has been getting worse.

Bravo, Catherine, for the discussion you and Joseph Farrell had on how Trump might go about establishing an equity-based rather than debt-based economy. I found it creative, insightful, and helpful for me to better understand the myriad forces he and we must contend with. I especially value your insistence that somehow we must establish open and honest dialog if we are to succeed. After generations of "talk radio" (what about "listen radio"?) and mainstream-planted mimes we've become divided into self-interest groups or turned-off from public process--except for the millions of folks who seek out information from sites such as yours and are ready or willing to become "Titanics." So how do we connect, communicate, and focus to recreate a public commons?

Clearly we can't depend on Main Stream Media nor are thousands of informative blogs and websites likely to do the job so long as they address only their identified audiences. Looks like it falls to the Titanics and their wannabes to create ways to get the job done. Some brainstorming: 1) Find a short name for the grass-roots movement to create meaningful productive dialog and use it (brand it). Enlist respected (even if dated) organizations known for their fairness and good will (the League of Women Voters and Common Cause come to mind) to come up with core questions that then can be addressed to the public and compiled by a highly professional polling organization and put out to the public via independent media and whatever MSM will publish it. 2) Begin a conspiracy for reputable sites and blogs to collaborate on finding and exploring the most pertinent issues, needs, and ways of achieving win-win scenarios. 3) Reinstitute regular local town hall meetings and Chataugas to define local needs and priorities and meet them. Get grants (Carnegie, Ford, and Rockefeller need not apply!) to coordinate and aid in sound processes and

growth. 4) Seek out and involve Millennials. Their creativity and numbers are essential (those who created the problem may not be the ones to fix it). 5) Basically, WE get to explore and recreate what brings us together and gets things done for the common good. Discussion PLUS action.
