1. GOVERNANCE DEBATE: Who runs our Executive Branch? The President or the Deep State

More US Strikes on Syria

From NBC News

The United States launched an airstrike against pro-Syrian forces who advanced inside a "de-conflicted zone" Thursday even though Russia urged them not to, the U.S.-led coalition said.

The airstrike appears to be the first publicly known direct confrontation between U.S. forces and fighters loyal to Syrian President Bashar al-Assad. While U.S. forces have engaged with ISIS fighters they have not previously been reported to have directly engaged with elements of the Syrian regime or militias allied with it.

Puerto Rico's first day in federal court to reduce its \$123 billion in bond debt and unfunded pensions got off to a cordial enough start on Wednesday, but after a few hours, the gloves started to come off.

The computer industry is now in the position of the auto industry in the 1960s. Reluctant to provide seat belts, air bags or other safety features, carmakers encountered government regulation. Then, with the principle of regulation established, the government went far beyond safety. In my view, the computer industry is naive in not thinking about the long-term consequences of its reluctance to evolve in security.

The Problem of Anonymity

Anonymity is one of the roots of the problem. Vandals and criminals are rarely caught because the principle of anonymity is built into the internet. This problem has been compounded by [the introduction of bitcoins](#), a form of financial transaction that attempts to maintain the anonymity of its users. The problem with anonymity is that while fostering freedom, it inevitably enables criminals to use that freedom for their ends. The attackers' demand for bitcoins in the latest event makes this point clear. This paradox – where the right to act without government scrutiny aligns with the rise of ruthless criminality – isn't new. As an empirical matter, however, a banking system that does not take responsibility for exposing criminals will find the state taking that role.

This is very much a geopolitical problem. It is not only, as many argue, that the current system enables cyberwarfare between states, but also that it facilitates organized crime on a global level. This problem is aided by an industry that builds products that make [cyberwarfare](#) and criminality relatively easy, an internet that makes identifying criminals – and state actors – relatively difficult, and now a banking system that is designed to make the finances of Borgias and Medicis appear the essence of ethics.

As a practical matter, what this situation will lead to is either the ever-deeper corruption of the state and insecurity of personal wealth, or the state imposing itself on the global computing system in as heavy-handed a way as possible. The idea that we are helpless in the face of cyberwar, constant vandalism and now criminal extortion, if true, will lead to the collapse of computing. Computing has become indispensable, but it is its very indispensability, facing constant threat, that will cause its collapse. You cannot be both indispensable and incredibly vulnerable.

As for me, the virtue of legal pads for important matters is becoming manifest.

Hi Catherine -

I am working on a report which will detail opportunities to unwind the legacy FFELP ABS and FFELP in general. I've spent most of my journalism career to-date focused on non-agency RMBS, ABS CDOs and derivatives. Then I started researching student loans and I couldn't agree more with the following statement you made in your September 2011 piece regarding William Diefenderfer. "I thought I had seen the worst that financial fraud could do to America. I was wrong. What has happened in the student loan industry over the last fifteen years is worse than anything I have seen before."

Right now I am compelled to find the achilles heal in the FFELP system and I'd love to hear more about your experience and run some thoughts past you.

Unfortunately FFELP borrowers are highly unlikely to receive the same type of assistance which I suspect will eventually be granted on a large scale to Direct Loan borrowers unless something changes. This is because of the way the FFELP loans are financed and the myriad vested interests attached to the FFELP system. Much of the vested interests orbit around Navient, which I suspect was spun off of SLM specifically for use as a dumping ground for not only SLM's undesirable 'assets' and liabilities, but also those of the major banks which financed FFELP loans. Banks continue to offload FFELP loans to Navi at par; they are then using a

combination of FFELP ABS and ABCP in order to pass the bullet of future non-payment and asset/liability mismatch on to AAA-rated securities investors.

The good news is economy of scale is declining in FFELP and there are a handful of loopholes which may be utilized to get the loans out of the deals so they can be restructured in the best interest of the borrower as opposed to the best interest of Navient's FFELP ABS residuals.

That said, here is where I'm primarily focused in regard to FFELP ABS and Navient:

- * Economy of scale is declining
- * NAVI's capital position is tenuous on declining volume
- * Banks are moving to offload remaining FFELP loans to NAVI while they can still sell them into it at par and finance them in ABCP facilities until they are securitized.
- * FFELP ABS maturity default issue impacting not only residual valuation but ability for deals to retain AAA ratings
- * Swap margin posting requirements threaten to erode economics of private student loan ABS at a time when ...
- * NAVI is looking to gain marketshare in private student loan refinancing space by cherry picking refinancing opportunities from its federal student loan servicing book
- * Can legacy FFELP ABS be restructured? What about student loans held in ARS trusts which have not turned over since February 2008?
 - * NAVI is in violation of the HEA's minimum financial standards for a third-party servicer (requirements is senior unsecured debt rating of A or higher, I believe, and NAVI's rating is Ba3) It's up to the ED Secretary to pursue this.
 - * Another avenue to pursue could be to flag basic loan processing issues (similar to robo-signing/chain of title issues in RMBS) as a means to unwind trusts.

I've been researching this sector for quite a while now and I just came across your work a few weeks ago. The vested interests run extremely deep. I've never seen anything like it. I hope you can speak with me on this topic ---- off record is completely fine.

I'd like to apply what I learn from Solari to break these dysfunctional patterns of ill treatment towards people, to create a business that honors and supports people so they can shine and enjoy their work and their lives. I'm hoping this small endeavor will have a positive ripple effect. But I wonder: with the constraints and paradigms of our current reality, is it possible to create a fabulous well-functioning local business in this mad world? Perhaps this is just a common challenge many conscious leaders face maneuvering in this realm?

What I also enjoy about your information is your optimism – there are so many nutty things going on with little hope of changing the current power structure but when you mentioned that big positive shifts can happen quickly – that’s exciting! :)

Catherine, I’ve been subscribing for almost a year and have listened to you on various radio shows for a number of years (CoasttoCoast, Caravan, etc). 1. My main question is about pensions and how to fight to get what I was promised. I have worked in a union in the printing industry for over 35 years. Back in the early 80’s, digital imaging systems were mainly located in prepress companies, and lasted through 1996 when the Mac and Photoshop became viable options. The union remained fairly strong until the 2008 financial depression, when companies consolidated or closed. I have seen both the positive and negative aspects of unions, just to express a realistic view of the system. The pension I was promised is now in “critical status” possible insolvency. At 60, this changes what my potential retirement will look like. I am unable to collect anything until 65. What options do I have to work to collect as much of what I have been promised over the year and counted on in my financial planning?

Audit, litigation, transparency

I’m working to write to my representatives. I believe that if the government can “bail out” the banks, it should protect the people who have produced throughout they’re working lives.

Yes, it could. However it is likely to unless you can get leverage through audio – website might help – open source the investigation.

2. Due to my reaction to the dot-com bust in the 2001-2002, I have not been in the stock market since that time. At this point with low interest rates, do you have any recommendations what to do with savings that are earning little interest? Is paying down debt (home equity, home mortgage) a good way to go?

DISINTERMEDIATION IS ALWAYS GOOD – shrink risk. So I don’t know what is best for an individual without knowing individuals specifics. But always like paying off debt
