Judge declares mistrial in Bundy case today

LAS VEGAS — A federal judge [declared a mistrial](#) Wednesday in the case against Nevada rancher Cliven Bundy, saying U.S. prosecutors willfully withheld critical and "potentially exculpatory" evidence from the defense.

Navarro cited five key pieces of evidence that prosecutors failed to disclose. That evidence, Navarro said, was favorable to the defense and could have changed the outcome of the trial.

It included:

- Records about surveillance at the Bundy ranch;
- Records about the presence of government snipers;
- FBI logs about activity at the ranch in the days leading up to standoff;
- Law-enforcement assessments dating to 2012 that found the Bundys posed no threat;
- And internal affairs reports about misconduct by Bureau of Land Management agents.

"Failure to turn over such evidence violates due process," Navarro said. "A fair trial at this point is impossible."

Acting Nevada U.S. Attorney Steven Myhre, who led the prosecution, did not make any comment after Navarro's ruling, and his office did not respond to interview requests Wednesday.

The Bundy Ranch standoff is one of the most high-profile land-use cases in modern Western history. It pitted cattle ranchers, anti-government protesters and militia members against the BLM over control of vast tracts of public land.

Federal prosecutors sat in silence Wednesday as Navarro spent about 45 minutes methodically laying out her reasoning for the mistrial. She cited legal standards and case law on the so-called "Brady rule," which requires prosecutors turn over evidence before trial that could be used to exonerate defendants.

She said it didn't matter if the failure to disclose was intentional or inadvertent. But Navarro detailed several instances where prosecutors denied evidence existed and used hyperbole to mock defense requests for information.

For instance, she said, prosecutors derided defense requests for a BLM internal affairs report into misconduct as a "bright shiny object ... that did not exist."

Dear Catherine Austin Fitts, What a nice surprise this was to receive when I talked with Darlene to suggest ideas to help you achieve the triumph of the decentralization-analog-counterforce-constitutional-morality-sound money polarity with Mr. Global you delineated in your recent youtubes! Your integrity, depth and commitment triggered me to call; thank you!

I think Pythagoras' idea that numbers are also qualities is fundamental so that the number of categories we use to study something determines the perspective and results we get.

I'm a legally blind linguist and astrologer with M.S. from Georgetown in linguistics and Chinese, certified in NLP and Huna, recommended by Harry Schultz (HSLetter #615, p. 4), friend of Bob Chapman (RIP) and was mentored by Chinese duchess-friend betrothed to the last emperor's brother because her father cured the Dowager's stomach cancer and the family's ancestor founded the Liang Dynasty in 501 A.d. I've keynoted for a Swiss asset-allocation firm re: cultural factors of investing and have traveled in over 70 countries.

My Russian semantics professor, who worked with Pentagon and Oak Ridge, said 1950s Russian ternary computers never crashed. A geek friend recently told me they probably used

oppositely polarized magnetization as well as non-magnetization per donut. Chinese characters are learned on a tick-tack-toe grid, not a Cartesian one. The third harmonic in music yields the fifth, whose circle of 12 approximates the multiplied-dual octave series. Theodor Illion in “Darkness Over Tibet” differently defines numerology by volume geometry, correctly describing Two as an alternate spiritual force, Three as spiritual potential of the triangle/Trinities and only Four as the first matter-containing volume—a tetrahedron.

I use the rock-scissors-paper analogy to describe the fundamental level of mind, where rock = ego-dominated people (88% according to marketing stats), who know their choices are limited, scissors = soul-dominated people (6%), who know their choices emerge out-side-the-box by cultivating creativity and paper = evil-dominated people (6% in Lobeczewski’s “Political Ponerology”), who always-and-only force choices by programming the rocks and tempting scissors to become rock to get the energy they—being parasites—refuse to self-generate. The world teaches us to play rock-scissors-paper backwards, which is impossible. Scissors is a plugged in tape recorder, rock is the recorder only on battery and paper is the time-decay until the battery dies.

The next level is Boolean logic regarding any content (A) per its context (B); Western and Middle Eastern cultures are adversarily dualistic A-not-B, suppressing context, e.g., “you’re either with us or against us.” Only Chinese culture is complementarily dualistic A-and-B, implying context, uniquely lacking a pre-Buddhist creation myth and able to answer the

proverb: “You’re not smart enough to live or brave enough to die; what are you going to do?” All other cultures are oppositionally dualistic A-or-B flippable content and context, e.g., a Huron chief asking the Jesuit: “Now don’t you want to hear our story about our Great Bear?” (Visually, A-not-B is a person on a seesaw in water held up because the unseen submerged end is weighted down, A-and-B is the yin-yang symbol with evolving opposite seed circles and A-or-B is a scale.)

I use more levels in cross-cultural counseling such as hierarchizing values by geographical region size/character and strength/weakness polarities for all cultures, where the extremes are overextensions of strength as in the martial arts. From the Richard Wilhelm edition of “I Ching,” Hexagram 43 (“Breakthrough”) I found four rules for dealing with evil:

- 1) 1) Combine strength with cheerfulness.
- 2) 2) Compromise with evil is impossible.
- 3) 3) Do not struggle directly with evil, lest you entangle your ego.
- 4) 4) Keep making progress in the good.
- 5) I have four more, one rule and three clear indications:
- 6) 5) Always be on the offensive against evil, never the defensive, using always-and-only forced choices against it, as it is necessary to use the rock/scissors/paper choiceframe “language” with each type/situation.

- 7) 6) Evil always-and-only takes shortcuts; good never does.
- 8) 7) Evil always-and-only seeks and causes confusion; good never does.
- 9) 8) And Evil alone and always is parasitic; good never is.
- 10) Catherine, it's always amazed me how sparse how-to instructions are in all scriptures, except the occasional "put on the armor of righteousness."
- 11) I've approached many officials with the need to sunshine CAFRs to show where the money is and went. I also think radionics work is needed on many levels
- 12) I wish you all the best for the turning of our world and humanity to the Light today and a Merry Christmas and Prosperous 2018. God bless you and I am eager to help you if you let me know how.

Hi Catherine, I listened to the Year End Tax Planning report and I wanted to direct your attention to the Roth Backdoor that really makes the discussion of contribution limits a moot point. Anyone of any income can contribute to a Roth IRA. The backdoor strategy has been around for at least 10 years. The way it works is for an individual to contribute to a non-deductible IRA as a first step and then subsequently transfer over to the Roth. I first was alerted to this option about 15 years ago on Bob Brinker and there are multiple white papers on it, but I think its an important consideration as part of any year end or year beginning tax planning.
